### 1. Management Plan for the Common and Woodlands

I have spent two days with John Morris looking in detail at the thinning required in Bois Wood and Tenterden Spinney under our first year of operations in the management plan. We have mapped trees to be felled or coppiced using our handheld GPS device, which then produces a location map for all the trees plus a database showing type of tree, girth of the trunk and action to be taken – this will be used in a specification of work to be sent out for quotations. 130 trees in Bois Wood and 38 trees in Tenterden Spinney have been identified (and sprayed with a yellow number) so note that there will be a considerable change in the appearance of these areas when work is carried out. There will be a separate replanting programme and we are examining whether we can get help with providing trees from The Woodland Trust. I note that Amersham Town Council recently had a community tree plant in Willow Wood and we will hopefully be able to arrange a similar operation.

#### 2. Burial Ground Maintenance

The Chiltern Rangers carried out a day of work in the meadow field, paid for by a £750 grant from the Natural Environment Partnership. About a third of the site has been mown and cuttings removed (we are now undertaking a rotational mowing regime), selected scrub on the chalk grassland area has been cleared, removing young ash and some hawthorn but leaving species such as field maple, and scallops along the top edge of the meadow have been created to soften the margin with the woodland. They also installed an owl nesting box.

Regular maintenance and grass cutting of all the burial ground areas has now started.

#### 3. Common Maintenance

Our new log seat adjacent to the pond has been installed.

We have received complaints from residents in Chestnut Lane about the state of the common land there resulting from the encroachment of vehicles as they try to pass one another when there is a line of parked cars making the road narrow. The CWBGMG is obtaining quotes on the cost of either installing wooden posts or creating an earth mound like that on North Road. so that the Council can consider options in due course.

### 4. Footpaths

The Parish Council now has devolved responsibility for the care and maintenance of the Public Rights-of-Way in Chesham Bois. Councillors are reminded to report on the footpaths designated on the attached list.

### **Other Items**

**HS2 exhumations:** The HS2 scheme requires the excavation of the cemetery of St Marys Church Stoke Mandeville which dates from the medieval period until the 1860s. Current estimates are that there may be about 4000 remains. HS2 have a requirement from the Archbishops Council that the remains are to be reburied together in 2021 and that a memorial is to be erected at the reburial site. The specialist who will be overseeing reburial has indicated that an area of 30m x 30m x 2m depth would be sufficient to accommodate the remains and would allow for the erection of a memorial. The design and structure of the memorial has not yet been determined but is likely to include both landscaping as well as a built structure.

The site will be consecrated, and it needs to be within the Diocese of Oxford and within the locality or region from where the remains were excavated. An existing cemetery rather than new land is preferred. Built Heritage has compiled a long list of sites that would be considered to meet the archbishop's criteria of 'locality' and 'region' and has written to CBPC seeking confirmation on two issues – first that we have capacity for these remains and second that we have no objection to be included in the process. Inclusion on the list entails nothing further, the process is that HS2 will select a short list and seek confirmation from the archbishops that the shortlisted sites meet their criteria. If CBBG were to be included on the shortlist it would be at that point that HS2 would enter into further detailed discussions with the parish concerning logistics, practicalities, costs, and benefits etc. The final preferred site would then be chosen by agreement between HS2, the Archbishops Council and the cemetery concerned.

The size of plot that is required is the equivalent of 300 double depth plots (or a maximum of 600 future burials). There is space of this size in the New Formal burial ground, equivalent to about a third of the capacity. Whilst we do currently have space in the burial ground, Council has a duty to consider and protect both the current and future needs of our own residents. Although CBPC is not closely local to the original Church site – many burial grounds in Bucks are demonstrating that they have very limited capacity at the moment, so are restricting plots only to their own residents, or already searching for new burial grounds. Many will have little capacity for such a large area to be dedicated. On that basis, whilst being on the long list does not imply the certainty that we would be shortlisted, any decision to join it must surely depend on the Council being content with the possibility that it will be the final site chosen.

As the plots would be paid for, there would be a large amount of income secured for the site in one year (which would need to be handled prudently to recognise that the maintenance of the site would be required over the life of the lease). The memorial and the stories attached to those buried would also generate both historical interest and profile for CBBG.

However, it does take up a significant section of the resource upon which Councils and their residents in many years hence will rely – the New Formal is only lightly committed at the moment, but its availability is what underpins our more personalised service of allowing people to choose plot location (rather than "next one along") and to welcome non-residents. There may also be debates amongst residents about the principal of these exhumations, particularly as this is to facilitate the controversial HS2 development. Council is asked to consider these competing issues when drawing up a response to Built Heritage.

### **Transport Working Group Report for 13 May 2019 Council Meeting**

### **Mobile Vehicle Activated Sign (MVAS)**

We now have 5 MVAS signs operational in the parish as detailed below:

MVAS 1 remains located in Bois Lane near the Church.

MVAS 2 remains located in Copperkins Lane at the junction of Deep Acres. This sign has a fault which has been reported to SWARCO.

MVAS 3 was relocated from the Amersham Road to North Road on 4 April 2019.

MVAS 4 remains located on the Amersham Road outside the Beacon school facing Amersham. The lock mechanism is broken on this sign so I'm unable to change the batteries. This has been reported to SWARCO.

MVAS 5 is located from 4 April on the Amersham Road outside the Beacon school facing Chesham.

No data has been downloaded this month.

The Council has entered into a maintenance contract with SWARCO from 1 April which covers 4 units out of warranty at a cost of £220pa per unit giving an annual cost of £880 for 2019/20.

#### **Street Lighting**

The new street lighting has been installed but not commissioned in Milton Lawns. The delay is with UKPN.

2018 street lamp replacements have been ordered by Sparkx but due to a problem with the supplier have not yet been received. I will keep council informed.

Sparkx have been successful in gaining access to the vicarage but have been unable to identify the power supply source to the street light in Glebe Way which has not working for at least 6 months. I have asked Sparkx to provide a quote to connect the light to the nearest street power supply and they estimate £5000 as the nearest supply is in Bois Lane or North Road.

Sparkx has also suggested an alternative solution. If we have a supply to the War Memorial at a cost of £6250, they would be able to provide a supply to the Glebe Way street light at a cost of c£2500. This would require moving the street light to the Triangle thus avoiding having to dig up the road in Glebe Way. To be discussed at the meeting.
